### PROFESSOR T.S. PAPOLA MERIT AWARD FOR THE BEST CONFERENCE RESEARCH PAPER BY YOUNG ECONOMIST

Prof. T.S. Papola Merit Award for the Best Conference Research Paper by Young Economist

A Merit Award has been instituted in the name of the outstanding economist Prof. T.S. Papola to encourage the participation of male economist below the age of 40 years as on the 31st March every year in the Annual Conferences of the Indian Economic Association. This award will ordinarily be given every year at the time of the Annual Conference of the IEA on the following terms and conditions effective from April 2010:

- 1. A cash award of the value of 5,000/-along with a certificate of appreciation will be given to the outstanding male paper writer who has contributed a full paper published in the conference volume and which has been adjudged to be the best paper of the concerned IEA conference by a collegiums constituted by the President of the Association comprising of at least three experts who had acted as the chairpersons of Technical Sessions besides the President and Secretary & Treasurer of the IEA.
- 2. Preference will be given to young male author coming from small town/ village of an under-developed state.
- 3. Only the first author of a joint paper shall be eligible for the award. However, the certificate of appreciation shall be given to all the authors.
- 4. The Secretary will ensure that the awardee is informed well in advance to enable him to present the paper in the conference of the IEA.
- 5. The selected awardee shall have to produce SS Exam certificate as proof of date of birth.

#### Held at A.N. Sinha Institute of Social Studies, Patna on 11.9.2010

- 1. The minutes of the last Executive Committee meeting held at KITT university Bhubneswar on 28 December, 2009 was confirmed.
- 2. The audited statement of accounts for the year 2009-10 was considered and approved.
- The next annual conference will be held at the Punjab University, Chandigarh with Dr. Gurmail Singh, HOD, Economics as Local Organising Secretary of the 93rd IEA conference.
- 4. The conference volume was decided to be published as a special issue of the IEJ. The president mentioned briefly the conference programme where there is a high probability of Prime Minister inaugurating the conference. The Local Organising Secretary was requested to see that the IEA members should not face any difficulty due to security reasons as it happened at the Bhubneswar Conference. It was further decided that Prof. M. Madaiah will be felicitated this year.
- 5. The appointment of the auditor B.C. Choudhary & Co. and Printer S. P. Printech was recommended and approved.
- 6. The proposal to enhance Donor & Patron membership fees was accepted.
- 7. Efforts to procure land in favour of IEA at Delhi on the basis of a meeting with Prime Minister were reported.
- 8. The report of the sub-committee for resolving the pending issues of membership during the tenure of the previous Secretary was placed and approved. The matter was finally closed.

- 13. Workshops to arrange research methodology course was approved.
- 14. President suggested the organization of pre conference seminar in Delhi in the 1st week of December in collaboration with the International Seminar.
- 15. At the end of the meeting members of the Executive Committee expressed their thanks and gratitude to the president Professor Sukhdeo Thorat for his dedicated services to the IEA to Make IEA an academically leading organization in the world. They also recorded their thanks to the President for his initiative to recognize the IEA conference volume as a special issue of the Indian Economic Journal and for providing a grant of Rs. 15 lakh to the Association.
